2. CONTEST PERIOD:

The Contest begins on June 15, 2016 at 12:00:00 a.m. Eastern Time (“**ET**”) and ends on June 22, 2016 at 11:59:59 p.m. ET (the “**Contest Period**”).

3. ELIGIBILITY:
